 Regular season practices begin in August. Games are played on Saturdays from September through November.

I understand that there are physical risks associated with, arising out of, and inherent to football / cheerleading. In recognition of this acknowledged risk of injury, I knowingly and voluntarily waive all rights and/or causes of action of any kind, including any and all claims of negligence arising as a result of such activity from which liability could accrue to Center Jr. Cougars, its officers, agents, employees, instructors, subsidiaries, parent corporations, and all affiliated entities (hereinafter referred to as "CJC"). I hereby agree to release CJC and hold CJC harmless of all liability, and hereby acknowledge that I knowingly and voluntarily assume full responsibility for all risks of physical injury arising out of active participation in football / cheerleading on behalf of the participant.

I am aware that this is a release of liability and an acknowledgement of my voluntary and knowing assumption of the risk of injury. I have signed this document voluntarily and of my own free will in exchange for the privilege of participation. If I am a minor, my parent/guardian has signed this document releasing CJC from any and all such liability described above and has acknowledged that I am knowingly and voluntarily assuming all risks of injury inherent to this activity. The above named participant has my permission to participate in all CJC events. I warrant the above information is complete and correct. I hereby authorize the event directors or their agent to act on my behalf to provide emergency medical treatments. I further release CJC of all liabilities associated with my child attending any CJC events. I also give CJC permission to use photos and/or video of my child in and/or on any form of advertisement. I understand that any fees paid are non-refundable. I understand that any fees paid do not guarantee my child a position on any CJC football team or cheer squad. All equipment remains the property of the CJC. I understand by signing this form that I accept responsibility for replacement cost in the event equipment is not returned, or is returned in poor condition. I understand that try-outs will be held for cheer and football, and my child's participation is subject to those try-outs. I also understand that previous participation in the CJC program does not guarantee my child a position with the association in the current calendar year. I am aware that it is mandatory for my child to participate in fundraising throughout the 2010 season.

I am aware of the mandatory \$100 Parent Participation deposit required for football and cheer participants, and of the mandatory \$100 Football Equipment deposit required for football participants, and I understand that deposits must be made at the time of registration. Registration is not complete until deposits are made.
